The number of each building on the street is given in numerical order, and opposite the number is placed the name of the occupants or houseowner or tenant. In the business blocks containing offices the occupants are shown by room numbers where practicable, in apartment homes the number denotes the number of the apartment. In all streets both sides of the street are included in one list. The profession or business of individuals or firms is given only at their respective place of business; to find occupation of others refer to Alphabetical List of Names.
