<p><b>WARNING</b></p> <p><b>GIVE UP YOUR PARTY LINE IN AN EMERGENCY</b></p>	<p>California Penal Code section 384 makes it a misdemeanor for any person who shall willfully refuse to immediately relinquish a telephone party line when informed that such line is needed for an emergency call to a fire department or police department or for medical aid or ambulance service. Also, any person who shall secure the use of a telephone party line by falsely stating that such line is needed for an emergency call, shall be guilty of a misdemeanor. "Emergency" means "a situation in which property or human life is in jeopardy and the prompt summoning of aid is essential."</p>
